

**No. 1050. THE PUBLIC RIVERS PROTECTION LAW.**

CAP. 143.

**ORDER IN COUNCIL No. 2883**

MADE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Public Rivers Protection Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

1. This Order may be cited as the Garyllis River (Protection) Order, 1956.

2. The portion of the public river Garyllis in the village area of Kato Polemidhia, in the District of Limassol, commencing from its junction with the Garyllis cutting at the north-west end of Plot No. 244, plan No. 54/57, locality Koupalaes, to a point where the river crosses the boundary between Kato and Pano Polemidhia villages, on the northern tip of plot No. 265 of plan No. 54/49, locality Ayios Vassilis Sontili, in the village of Kato Polemidhia more particularly defined as the area coloured red on the Government Survey Plan, Serial No. Blue 42, filed in M.P.305/45 in the Office of the Commissioner, Limassol, is hereby declared to be a river for the purposes of the Public Rivers Protection Law.

3. This Order shall be in addition to the Garyllis River (Protection) Order, 1931.

**THE CUSTOMS (WHARFAGE DUES) LAW, 1955.**

**ORDER IN COUNCIL No. 2884**

MADE UNDER SECTION 5.

In exercise of the powers vested in him by section 5 of the Customs (Wharfage Dues) Law, 1955, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

1. This Order may be cited as the Customs (Wharfage Dues) (Revision) (Amendment) Order, 1956, and shall be read as one with the Customs (Wharfage Dues) (Revision) Order, 1955 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Customs (Wharfage Dues) (Revision) Orders, 1955 and 1956.

2. The part of the principal Order headed “ (A) WHARFAGE DUES FOR IMPORTS ” is hereby amended as follows :—

(a) by the insertion therein, immediately after item 12, of the following new item :—

<i>Item No.</i>	<i>Description of Goods.</i>	<i>Rate.</i>
“ 12A.	Fresh fruit in any receptacle ..	20 mils per cwt. or part thereof ”;

(b) by the insertion therein at the end of the portion thereof headed “ EXEMPTIONS ”, of the following new paragraphs :—

“ 8. Goods imported or cleared by or on behalf of the Governor for his use, and, in the absence of the Governor, imported or cleared by or on behalf of the Officer Administering the Government for his use.

9. Any materials or goods imported free from any customs duties by virtue of any licence granted under section 3 of the Cement Industry (Encouragement and Control) Law, 1952, or any Law amending or substituted for the same.”

3. The part of the principal Order headed “ (B) WHARFAGE DUES FOR EXPORTS ” is hereby amended by the deletion of paragraph (a) of item 14 thereof and the substitution therefor of the following paragraph :—

<i>Item No.</i>	<i>Description of Goods.</i>	<i>Rate.</i>
“ (a)	Raisins in any receptacle .. ..	20 mils per ton or part thereof.”.

## THE WELLS LAW.

CAP. 312 AND LAWS 19 OF 1951 AND 42 OF 1953.

### ORDER BY THE GOVERNOR UNDER SECTION 3A.

In exercise of the powers vested in him by section 3 (a) of the Wells Law, His Excellency the Governor hereby defines for the purposes of the said section the area set out in the Schedule hereto as area in which no permit for the sinking or construction of a well shall be issued by the Commissioner and no variation or modification of any condition or restriction imposed on any such permit shall be effected, save with the concurrence of the Director of Water Development, in accordance with the provisions of the said section.
