ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia and Kyrenia District No. 4) Order, 1956.

2. No person within the area of Nicosia Town described in Schedule I hereto shall be out of doors on the dates and during the hours prescribed in Schedule II hereto except under the written authority of the Commissioner of Nicosia or the Assistant Commissioner of Police or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force at 13.30 hours on the 14th day of March, 1956.

SCHEDULE I.

From the Southern end of Ledra Street along Regaena Street—up Phokion Street to Arsinoe Street—Onassagoras Street to Sophocles Street into Solon Street, along Sappho Street, down Aeschylou Street to Constantine Paleologou Street and back to the Southern end of Ledra Street.

SCHEDULE II.

From 13.30 hours on Wednesday the 14th March, 1956, until further notice.

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 14th day of March, 1956.
