Within the area prescribed in the First Schedule hereto no Greek or Turkish Cypriot male or female person born on or after January the 1st, 1930, shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Chief Constable in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force or any Government employee.

This Order shall come into force on the 9th day of February, 1957.
