THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.

AMENDMENT OF ORDER MADE BY THE GOVERNOR UNDER  
DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor hereby amends the Order made by him under Defence Regulation 64 and published under Notification No. 275 in Supplement No. 3 to the *Gazette* of the 14th March, 1957, by deleting the reference to Plot Nos. 43, 60 and 44 appearing in the fourth line of the Second Schedule thereto.

THE BURIALS LAW.  
CAP. 53 AND LAW 33 OF 1955.

ORDER UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Burials Law, Cap. 53 and Law 33 of 1955, and delegated to me by Notification No. 172, published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia Districts, do hereby order that a new burial ground shall be provided under the provisions of the said Laws, for use by the Turkish community of the village of Kambyli, in the District of Kyrenia, in lieu of the burial ground now in use by the said community.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Nicosia and Kyrenia, hereby

take possession of the land and in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the premises in pursuance of this Order are hereby authorized to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

SCHEDULE.

All the privately owned land situated at Pyroi village, Nicosia District, that is to say :—

The land forming parts of plot Nos. 43, 44 and 60 of the Government Survey Plan XXXI.35 more particularly defined as the area coloured red on the plan Drawing No. 594 copy of which is kept in the office of the Commissioner of Nicosia and Kyrenia.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 2) 1957.**

ORDER MADE UNDER REGULATION 44.

Whereas by Order dated the 28th November, 1956, published in Supplement No. 3 to the *Gazette* of the 3rd January, 1957, under Notification No. 30 (hereinafter referred to as "the Order"), I authorised the use by the Security Forces of the property set out in the Second Schedule to the Order, situated in Pano Platres, Limassol District (hereinafter referred to as "the property"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas I am satisfied that the property should continue to be used by the Security Forces for a further period of six months as from the expiration of the Order :

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 2) 1957 and delegated to me under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, Robert Chattan Ross-Clunis, Commissioner of Limassol, do order that the aforesaid authorisation for using the land by the Security Forces subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 2nd April, 1957, and the Order is so extended accordingly.
