THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

THE PRISON DISCIPLINE LAW.
CAP. 266 AND LAW I OF 1953.

PRISONS (PRISON SERVICE) (AMENDMENT) REGULATIONS.

In exercise of the powers vested in him by section 6 of the Prison Discipline Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations :—

1. These regulations may be cited as the Prisons (Prison Service) (Amendment) Regulations, 1957, and shall be read as one with the Prisons (Prison Service) Regulations (hereinafter referred to as "the principal Regulations").

2. Sub-paragraph (a) of Regulation 11 of the principal Regulations is hereby amended by the substitution for the word "ten" in sub-item (ii) of item "n" of the word "fifteen".

3. Sub-paragraph (b) of Regulation 11 of the principal Regulations is hereby amended by the substitution for the word "two" in sub-item (i) of item "q" of the word "ten".

1. These Regulations may be cited as the Prison (Amendment No. 2) Regulations, 1957, and shall be read as one with the Prison Regulations (hereinafter referred to as "the principal Regulations").

2. The principal Regulations are hereby amended by the deletion from the fourth line of the second column of Appendix 'A' of the words "40 drams three times weekly" and the substitution therefor of the words "280 drams weekly".

In exercise of the powers vested in him by section 3 of the Motor Vehicles and Road Traffic Law, 1954, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following Regulations:—

1. These Regulations may be cited as the Motor Vehicles (Amendment No. 2) Regulations, 1957, and shall be read as one with the Motor Vehicles Regulations, 1951 to 1957 (hereinafter referred to as "the principal Regulations") and the principal Regulations and these regulations may together be cited as the Motor Vehicles Regulations, 1951 to (No. 2) 1957.

2. Regulation 16 of the principal Regulations is hereby amended by the addition thereto of the following paragraph, the first part of the said regulation being numbered as paragraph (1):—

"(2) No other figures or letters shall be placed near to the identification marks in such a manner as to be liable to render it more difficult to read or distinguish the identification marks of the vehicle when in motion."
